STATE ECONOMIC OUTLOOK

- The Department of Finance (DOF) reports that state revenues for the 2022-23 fiscal year is currently \$3.3 billion below Governor Gavin Newsom's estimates from January, when he released his 2023-24 State Budget proposal.
- Legislative Analyst's Office projection that there is an 80% chance that revenues for fiscal year 2022-23 would be approximately \$5 billion lower than the Governor's January estimates by the time the Legislature adopts the 2023-24 State Budget.
- The fiscal year-to-date shortfall would result in an approximate \$1.3 billion reduction in the Proposition 98 minimum guarantee while a \$5 billion shortfall would further reduce K-14 funding by another \$700 million.
