### COVID-19 Updates

The Governing Board engaged in a discussion detailing how the District is navigating the COVID-19 pandemic. Mr. Arik Avanesyans, Assistant Superintendent of Business Services, led the discussion focused on the hybrid reopening of schools for in person instruction. Mr. Avanesyans also shared a slideshow of photos from the first day of hybrid instruction with Trustees.

### Parliamentary Procedure

President Dalla led a discussion with Trustees regarding the consideration to adopt specific parliamentary rules of order for Governing Board meetings. Trustees expressed interest in moving forward with Training on Rosenberg's Rules of Order for future adoption.

### Reclassification

Educational Services Director, Beverly Hayes, gave a presentation outlining National School District's English learner reclassification procedure and criteria. Reclassification is the process that a student is classified from English Learner (EL) status to fluent English proficient (RFEP) status. Our District reclassification criteria is as follows:

- Overall score of 4 on the summative State assessment English Language Proficiency Assessment (ELPAC).
- Data of basic skills relative to English proficient peers with iReady normed scale score for grade level in reading.
- Teacher review using language rubric and reading level score.
- School staff parent consultation meetings discussing process and parent signature on reclassification form.
