LCAP and Budget

The Governing Board unanimously approved the National School District's 2021-2022 Local Control Accountability Plan (LCAP) and corresponding Local Control Accountability Plan (LCAP) Federal Addendum for the 2021-2022 school year. In addition, the Board voted 5-0 to approve the Estimated Actual Budget for 2020-2021 and adopt the 2021-2022 Proposed Budget for all funds; as well as corresponding resolution #20-21.49 for the use of Education Protection Account (EPA) funds for the 2021-2022 school year.

Public hearings for both the LCAP and Budget were held at the June 9, 2021, Board meeting.

The Board voted unanimously to renew the petition submitted by Integrity Charter School.
