Pulled/Corrected Items

A request was made by staff to pull two items from the consent agenda:

12.A.I. for clarification and be brought back at a subsequent meeting.

12.C.I. for correction that Language Arts Specialist be changed to Speech and Language Pathologist. The Board voted unanimously to approve the action with this change.

BP 0415- Equity

To ensure a welcoming and inclusive District, the Board revisited existing Board Policy 0415- Equity and discussed potential updates. A request was made by Trustee Gates for more time to consider input before recommending any potential updates. President Dalla stated that she will add it to the next agenda for additional discussion.

Meeting Streaming Options

Bryan Lucero, Electronic Systems Technician, gave a presentation regarding virtual streaming options. Mr. Lucero recommended an internal solution to provide the best cost and flexibility for the District. The Board provided input for moving forward with this solution.
