
Postponed

GASB No.75 Actuarial Valuation Report



GASB 75 requires a full actuarial valuation at least every two years for post-employment benefits. The term "post-employment benefits" refers to benefits earned during employment but used after employment has ended. The most common example of post-employment benefits, other than pensions, is retiree health benefits. Sandy Dekalb from Nyhart provided Trustees with a brief presentation. Trustees voted unanimously to accept the report.
